**Re: Non-Circumvention and Exclusivity Letter Agreement**

Dear Mr. Zoran:

This Letter Agreement ("Agreement") dated **November 21, 2024** ("Effective Date") confirms the understanding and agreement reached between Summit Nutritionals International, Inc.® ("Summit") and Kupidon-SP d.o.o. ("Kupidon"). Individually, Summit and Kupidon may be referred to as a Party and together as the Parties.

**WHEREAS**, the Parties believe that an agreement with respect to existing customers of Kupidon interested in purchasing Droi-Kon® Chondroitin Sulfate exclusively through Summit would be to their mutual beneficial interest, the Parties agree as follows:

1. **Term.** This Agreement has a term of one (1) year following the Effective Date set forth below (the "Term") and may be renewed upon an express writing to such effect executed by the Parties. Otherwise, this Agreement shall lapse and be of no further force and effect following the conclusion of the Term.
2. **Non-Circumvention.** Summit agrees that during the Term of this Agreement, Summit shall contract for the sale of Droi-Kon® Chondroitin Sulfate, regardless of species, exclusively through Kupidon for the territory of Serbia, exclusively and any territory in the European Union where Kupidon shall solicit and if they are not already an existing Summit customer.
3. **Exclusivity.** In exchange for Summit's agreement of non-circumvention set forth in Section 2 above, Kupidon agrees that it shall purchase chondroitin sulfate, regardless of species, sold by Summit exclusively through Summit for Kupidon Customers and will not purchase such product(s) through any other supplier, distributor or vendor as to such customers.
